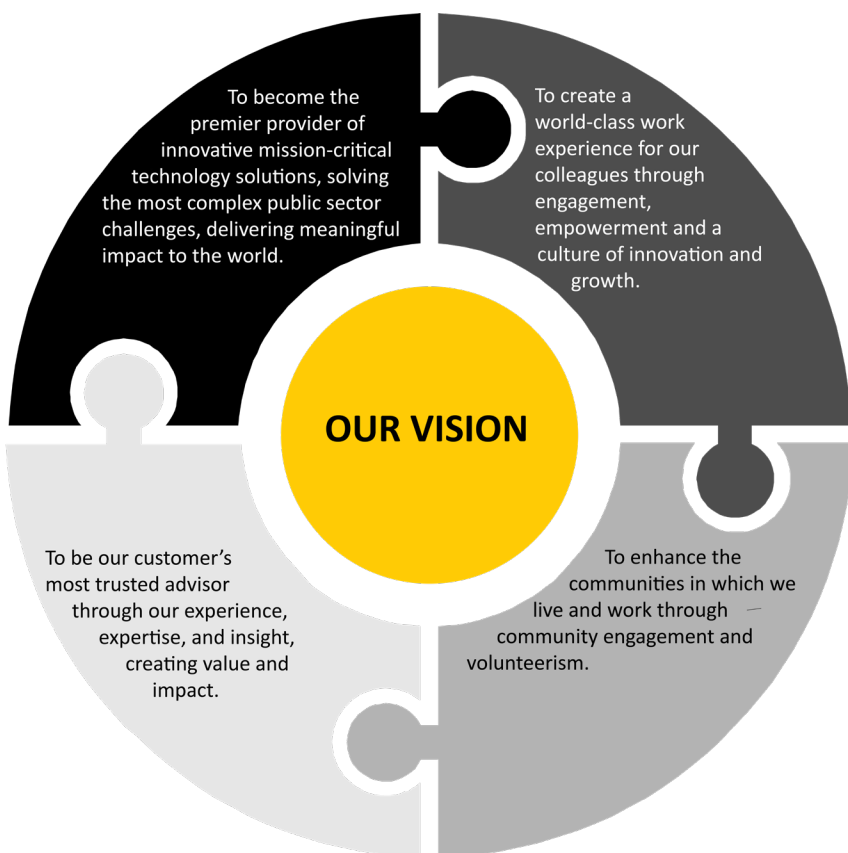

BENEFIT DETAILS

- ✓ Intelligent Waves provides U.S. based team members 120 hours of accrued Paid Time Off (PTO) per year. Internationally based team members accrue 160 hours of PTO per year. Vacation hours are accrued on a semi-monthly basis. Team members can carryover a maximum of 160 hours of accrued/unused PTO into the next year.
- ✓ IW offers 80 hours of paid parental leave to any employee who has a new child in the home via birth or adoption.
- ✓ Intelligent Waves recognizes and offers eleven paid holidays as well as one floating holiday for a total of 12 paid holidays a year.
- ✓ Intelligent Waves will reimburse employees up to \$5,250 for pre-approved educational costs per calendar year. Educational costs include tuition/courses, books, tests and certifications. Employees are eligible for the education program after 90 days of employment.
- ✓ Intelligent Waves offers team members the opportunity to contribute to a 401(k) savings plan administered by Principal Financial Group. Intelligent Waves will match both pre-tax and/or Roth elective contributions, dollar for dollar up to 3% of pay and 50 cents for each additional dollar between 3% and 5% of eligible pay. The contribution is called a safe harbor matching contribution. Team members are always 100% vested in the safe harbor matching contribution. There are numerous investment options.
